# Gaeseong Industrial Complex(GIC)



## *Opening an era of peace and prosperity*

Combining capital and technology of the South with the land and labor of the North, the Gaeseong Industrial Complex (GIC) aims to bring economic benefits to both Koreas.

The GIC is a new way out for South Korean small and medium-sized enterprises to overcome existing high costs, low efficiency and labor shortage while also benefiting the North Korean economy.

Hundreds of businessmen and vehicles are passing through a Gyeongui road line across the Demilitarized Zone every day to run their businesses. This project contributes to building mutual trust, promoting peace and establishing a foundation for unification on the Korean peninsula.



## *Location*

The Gaeseong Industrial Complex(GIC) is located about 38 miles(60 kilometers) north of Seoul, the capital city of the Republic of Korea. It takes one hour to travel by car. The GIC is approximately 100 miles(160 kilometers) from Pyeongyang the capital city of DPRK. Located 31 miles (50 kilometers) from Incheon International Airport, the GIC has direct links to the world's markets through Incheon International Airport and Incheon Port.

In the near future, links to the Trans-Siberian Railroad and Trans-China Railroad will be completed, making transportation and distribution easier.

## Current Status

As of Aug 2011, a total of 123 companies are in operation at the GIC.

The cumulative total production within the GIC (from January 2005 to Aug 2011) reached US\$1,366 million. The total export value from the Complex over the same period amounts to US\$185 million.

Currently, 47,758 North Koreans and 798 South Koreans are working in the Complex. North Korean workers receive monthly salaries of approximately US\$117.9(including 15 percent social insurance fees).

Many overseas investors such as EU Executive Board, EU Chamber of Commerce, ASEAN FTA negotiating team and the Diplomatic Corps in Korea visited the GIC and showed high interest in facilities and competitiveness of the GIC.



# Products

GIC, which already houses 123 companies, are producing everything from clothing and shoes to semiconductors, electronics and communication parts, from plastics and kitchen utensils to watches and jewelry.



Since the first Gaeseong-made products appeared in December 2004, their excellent quality, thanks to a first-class workforce, has been widely recognized. Gaeseong-made products will be capturing the attention of the whole world soon.



# Investment



To invest in the GIC, a foreign enterprise has to establish a foreign investment corporation(minimum 50million won investment is required) in the South, buy building lots and get approval of the government of South Korea.

Currently, 6 lots of land(110,160m<sup>2</sup>) are allocated to several types of industries such as electricity and electronics to attract foreign investment and 3 lots(49,134m<sup>2</sup>) of them are sold to German, Chinese and other investment corporations.



# *Support for Overseas Sales*



With labor costs highly competitive with China or Vietnam, the GIC has the potential to become an economic hub of Northeast Asia.

The products produced in the GIC are brought in South Korea and then exported to the foreign states. The government of South Korea is promoting Free Trade Agreement to expand export of the products made in the GIC.

Under the terms of FTAs with the ASEAN, the EFTA, Singapore, Indo and Peru, goods produced in Gaeseong will receive preferential tariffs in those markets.



## *Leaping into the world*

Production at and exports from GIC continue to rise rapidly still today. With the North Korean employees becoming increasingly familiar with the work, production is stable and constantly improving. And with this success has come the growing attention of companies the world over. Quite apart from the goal of cooperation between the North and the South, Gaeseong is moving toward becoming a Northeast Asian industrial hub in its own right.
